The company has manufacturing facilities in Niagara Falls an in the Netherlands and is currently engaged in a site selection process to locate a worl class Feed & Food additive facility which will operate 24 hours a day, seven days a week. The Company is considering locations in Alabama, Louisiana and New York (on vacant land at Niacet's current Niagara Falls plant). There is a significant cost differential favoring the Southern U.S. locations vs. New York State. The project will require 14 new full-time employees to staff the manufacturing facility by the end of 2018 and will entail construction of a new manufacturing building and significant capital investment in new production equipment.	0000
