| YMCA Buffalo / Niagara Town of Lockport | To remain financially viable and meet the current needs of Lockport and the surrounding communities, the YMCA needs to replace the 90+ year old building on East Avenue in the City of Lockport with a new, fully accessible facility with the capacity to serve large numbers of people of all ages. The new building will provide traditional YMCA membership and programs such as fitness activities, swim lessons, youth sports, after school programs, summer day camp, preschool education, etc. The facilitation of a tax-exempt bond issue will enable the YMCA to finance the large capital investment necessary to construct such a facility. Without low cost, tax-exempt financing, the interest expense associated with more traditional forms of commercial financing would be too burdensome for the operation of the facility. | \$17,000,000 Existing Jobs 23 New Jobs 19 FTE's |
| Summit Outlet, LP Town of Wheatfield | In 2014, Zoran Cocov purchased the mostly vacant Summit Mall and did extensive research on how to repurpose the structure by phasing in projects over the next 5-10 years. The first phase will include the erection of two 96,000 square foot sports domes, (soccer, baseball, volleyball, basketball), on the east side of the existing mall in the rear parking area. These domes will also be used during the off season for trade shows and conventions to continue to bring traffic into the area.
