18 Finance for the Niagara County Industrial
19 Development Agency. I'll be serving as hearing
20 officer for this public hearing. It is now 3:32 p.m.

22 solicit comments, both written and oral, on the
23 Mayer Brothers Apple Products, Inc. project in the

1 Town of Somerset.

2 The company will construct a
3 44,000 square foot addition at 7389 Lake Road to
4 provide additional juice-bottling production and
5 distribution space.
