Irr Supply Centers is an owner occupier and landlord of the property. The project is a proposed renovation and modernization of the location. Irr Supply has been reviewing locations for its distribution center and would propose a project that would prevent relocation and renovate the facility to make it more conducive for its use and support its growth. The scope would include the modernization and repair of the facility including asbestos abatement, office equipment, computer upgrades, and material handling equipment.

This year we are losing a major manufacturing tenant Erie Engineered Products moving 48 jobs to Erie County. We are currently negotiating with Commercial Fabrics a manufacturing tenant to extend their lease, which will require building renovation and repair for them to stay. The motivations of this project are twofold, first take a building that is an out-dated factory and reconfigure the building for Irr Supply Centers, Inc. to allow for future investment in this location and support its growth of employment and the need for improved operational efficiency. Second would be to provide an improved location to keep current manufacturing in the facility and attract new business and potential employment to this location.
