Company), a New York limited liability company, with offices at 2087 Transit Road, Burt, New York 14028, for itself or on behalf of an entity formed or to be formed (the "Company"), has submitted an application to the Agency, a copy of which is on file at the office of the Agency, requesting that the Agency consider undertaking a project (the "Project") consisting of: (A) the acquisition (or retention) by the Agency of fee title to or other interest in a parcel of land located at 2087 Transit Road in the Town of Newfane, Niagara County, New York (the "Land"); (B) the construction of an approximately 24,000 square foot addition to the existing facility to be used for the expansion of the Company's fresh apple packing and shipping facility (the "Improvements"); and (C) the acquisition of and installation in and around the Improvements of certain manufacturing machinery, equipment and items

of personal property (the "Equipment") and collectively, with the Land and the Improvements (the "Facility").

The Agency will acquire or retain title to, or a leasehold interest in, the Facility and lease the Facility back to the Company. The Company will operate the Facility during the term of the lease. At the end of the lease term, the Company will purchase the Facility from the Agency, or if the Agency holds a leasehold interest, the leasehold interest will be terminated. The Agency contemplates that it will provide financial assistance to the Company for qualifying portions of the Project in the form of sales and use tax exemptions and a mortgage recording tax exemption, consistent with the policies of the Agency, and a partial real property tax abatement.
