- 1.0 The meeting was called to order at 9:12 a.m. by Vice Chairman Updegrove.
- 2.0 Roll was called. Board members present were Vice Chairman Richard Updegrove and Secretary Michael Casale.
- 3.0 The minutes of the December 19, 2023 Board of Directors meeting were motioned for approval by Mr. Updegrove and seconded by Mr. Casale. Carried.

ACTION ITEMS

Resolution NCBDC-032023-01 – Michael Thomas of Harrison Studio and Lou Visone of DLV Properties were present to discuss the project. Ms. Fisk stated that the current remediation of 624 River Road is being completed in phases and additional expenses incurred require additional funding. As the Fund Manager for NCBDC, Mr. Thomas explained his review of the project financing, Mr. Thomas stated there has already been a \$2.7 million equity investment into the project and based on the current percentage of cleanup completion, the requested loan represents a low risk for the NCBDC. Completion of cleanup and redevelopment at the adjacent 600 River Road proves the competency of DLV Properties to complete the project at 624 River Road. Ms. Fisk stated that both the Niagara County Health Department and EPA has recommended approval of the loan. Mr. Visone informed the board that there have been several unforeseen factors that have caused an increase in expenses including pre-existing conditions from the prior industrial facility and an increase in the cost of materials. A motion to approve the \$1,000,000 loan from the BCRLF to DLV Properties was made by Mr. Updegrove and seconded by Mr. Casale. Carried.

NEW BUSINESS

- 5.0 Ms. Fisk updated the board of the following:
 - a) An advertisement in the publication Business First will run on April 1, 2023 promoting the availability of brownfield funding.
 - b.) A subgrant application from the Town of Wheatfield for remediation at 2020 River Road in the town will be presented to the board in the near future.
